Bidders may download the bidding documents for e-submission from E-procurement section of PPMO's Web Site <http://www.bolpatra.gov.np/egp> Bidders, submitting their bid electronically, shall deposit the fee (as specified above) of bidding document in the account as specified below and the scanned copy (pdf format) of the Bank deposit voucher shall be uploaded by the bidder at the time of electronic submission of the bids.
7. Bids must be valid for a period of 90 days counting from the day of bid opening and must be accompanied by bid security from "A" class commercial bank, which shall be valid for minimum 120 days counting from the day of bid opening.
8. If the Bidder wishes to submit the Bid Security in the form of cash, the cash should be deposited in Nepal Bank Limited Deposit Account No. 01801000002003000001 and submit the original copy of receipt of the

deposited amount of cash along with the bid. The scan copy of receipt of bid security must be submitted at the time of bid submission for electronically bid submission process.

9. Pre-bid meeting shall be held on the 25th March, 2021 at 13:00 Hrs at Central Agriculture Laboratory, Hariharbhawan.
10. Sealed Bid must be submitted to <https://bolpatra.gov.np/egg/> on or before 12.00 hours on 4th April, 2021. Documents received after this deadline shall not be accepted.
11. Bids shall be opened in the presence of Bidders' representatives who choose to attend at 13.00 hours on 4th April 2021 at Central Agricultural Laboratory, Hariharbhawan.
12. If the last date of purchasing, submission and opening falls on a government holiday then the next working day shall be considered the last day. In such a case the bid validity and bid security validity shall be recognized with effect from the original bid submission deadline.
13. The Purchaser reserves the right to accept or reject, wholly or partly any or all the bids without assigning reason, whatsoever.
14. Bidder must submit the bid document sold by Central Agricultural Laboratory, incompletely filled bids or essential documents not in format provided by Central Agricultural Laboratory, Hariharbhawan, will not be acceptable. Bidder must attach brochure and offer list showing specification and offered model and can attach additional document when required.
